





The Commissioner of Collegiate Education, has forwarded the application submitted by the Jaya Educational and Cultural Society, Thiruninravur to open an Un-aided Private College (co-education), in the name of "Jaya College of Arts & Science" at Thiruninravur, Chongai-M.C.R. District, during 1992-93. The Commissioner of Collegiate Education has stated the following:-

1. The management has not created an endowment of Rs.10 lakhs (Rupees ten lakhs only) in the name of the Commissioner of Collegiate Education and the Management.
2. The management has purchased 5 acres of land in Manlicherry Village, Sriperumbudur Taluk in S.No. 133/1, 135/2, 135/1, 135/2, 137/1 and 133/2 and the document registered on 13.11.91 in the Sub-Registrar's Office, Poonamallee. There are encumbrances in the lands purchased for the purpose of the College and that a dispute regarding the same is pending in the Poonamallee Court.
3. The management has not executed an agreement on paper to abide by all the conditions prescribed by the Government.

2. The Government have examined the proposals and order as follows:

1. The land purchased by the said Trust indicated in para 1(2) above should not be utilized for any purpose other than College purpose.
2. The management is now permitted to start the College during 1992-93 in the Jaya Matriculation High-Secundary School buildings at Thiruninravur temporarily for one year and it should be shifted to a permanent building during 1993-94 to be constructed on the land mentioned in para 1(2) above.





At the end of the period of suspension, work may be resumed with the previous approval of the Syndicate. If the work is not resumed at the end of the period of suspension, the affiliation or approval previously granted shall be regarded as having lapsed".

As per the above Statute, the colleges should obtain prior permission from the University before Suspension / Revival of course(s) for the forthcoming academic year 2018-2019.




